\_\_\_\_\_ **DEADLINES FOR FILING**

1. Petition: 30 days after entry of decision of Court of Appeals, or decision on petition for rehearing. (Check for Extension Order)
2. Cross-petition: 30 days after service of petition.
3. Respondent: 30 days after service of petition.

\_\_\_\_\_ **SEVEN COPIES** (1 original + 6 copies) *effective 4-1-05* (see R. 48(f), URAP)

\_\_\_\_\_ **LENGTH**

1. Petitioner 20 pages
2. Opposition 20 pages
3. Amicus 20 pages

\_\_\_\_\_ **SIZE AND BINDING**

\_\_\_\_\_ **PRINT AND COVER REQUIREMENTS**

1. 10 characters per inch; double spacing; *effective 4-1-98*, proportional spaced typeface must be 13 points or larger for both text and footnotes; mono-spaced typeface may not contain more than 10 characters per inch for both text and footnotes.
2. Print on both sides of the page.
3. **Color:**

6. Statement of jurisdiction. (Petitioner only)
7. Constitutional provisions, statutes, ordinances, and rules. (Pet. only)
8. Statement of case. (Petitioner only)
9. Argument.
10. Appendix: Court of Appeals and lower court decisions. (Petitioner only)
11. Attorney Signature.
12. Proof of Service.
