

**QUICK REFERENCE TO E-FILING DOCUMENT TYPES: DOMESTIC CASES**

1. Documents that require special processing by court staff must be filed by document name.
2. Choosing the correct document name will expedite your filing and facilitate management of your case.
3. If the document you are filing is not on this list, it should be filed as Other in a PDF format.

2. On the Judgment Cause of Action Screen, select the appropriate Judgment Type. Use Judgment only when the order awards monetary damages. Use Default Judgment only when the order awards monetary damages and the Judgment was not contested.
3. Add appropriate Judgment Details in the Edit Judgment Cause of Action screen.
