After the elapse of ten days from the date of this notice, if the application is found to be complete and in compliance with the Utah Uniform Probate Code, it will be granted.


You may object to the relief requested by stating an objection and filing it with the court clerk located at 845 East 300 North, Richfield, Utah 84701 within ten days of the date hereof.
