

1 Rule 1-201. Membership - Election.

2 Intent:

3 To establish the manner of election of Council members as authorized by statute.

4 To establish the procedure for filling a vacancy on the Council as authorized by
5 statute.

6 Applicability:

7 This rule shall apply to all elected members of the Council. This rule shall not apply
8 to the Chief Justice of the Supreme Court.

9 This rule shall apply to the Boards of Judges and the Board of Commissioners of the
10 Utah State Bar.

11 As used in this rule, unless the context indicates otherwise, "Board" includes the
12 Boards of Judges and the Board of Commissioners of the Utah State Bar.

13 Statement of the Rule:

14 (1) The composition of the Council, the term of office of elected Council members,
15 and the electorate of elected Council members shall be as prescribed by law. The term
16 of office of all elected Council members shall begin with the October meeting of the
17 Council.

18 (2) Election of Council members from courts of record shall take place at the annual
19 judicial conference. Election of Council members from courts not of record shall take
20 place at the annual spring training conference of the justice court judges. Election of the
21 representative of the Utah State Bar shall take place at a regularly scheduled meeting of
22 the Board of Commissioners.

23 (3)(A) If a judicial member of the Council who represents a trial court is unable to
24 complete a term of office, the Board for the court represented by that member shall
25 appoint a judge to serve on the Council until the next judicial conference or the next
26 spring training conference as the case may be. At such conference, the judges shall
27 elect a member to the Council to serve for the unexpired portion of the original term. If a
28 judicial member of the Council who represents an appellate court is unable to complete
29 a term of office, the members of that court shall appoint a judge to serve on the Council
30 until the expiration of the vacated term.

31 (3)(B) If the representative of the Utah State Bar is unable to complete a term of
32 office, the Board of Commissioners shall elect a member or ex officio member of the
33 Board of Commissioners to serve for the unexpired portion of the original term.

34 (3)(C) No person shall serve on the Judicial Council for more than two consecutive
35 terms and the remainder of a predecessor's term.

36 (4) The Boards shall develop procedures for the nomination and election of Council
37 members and shall certify to the Council the names of the members elected. The
38 Boards shall give due regard to geographic representation, security of the election,
39 timely publication of Council vacancies or expired terms, and ease of administration.

40 (5) When a judicial member of the Council is unable to attend a Council meeting,
41 that member may designate a judge from the same level of court to attend the Council
42 meeting and observe the proceedings. When the representative of the Utah State Bar is
43 unable to attend a Council meeting, that member may designate a member or ex officio
44 member of the Board of Commissioners to attend the Council meeting and observe the
45 proceedings. The designee shall be provided with a copy of the Council agenda and
46 other meeting materials, and may attend the open and closed sessions of the meeting.
47 The designee may ~~respond to questions but may not~~ participate in the general
48 discussion of agenda items; but may not make motions or vote on Council issues.

49 (6) Council members or their designated substitutes may be reimbursed for actual
50 and necessary expenses incurred in the execution of their duties as Council members.

51 (7) Council members shall not be eligible to serve as voting members of the Boards
52 of Judges or to serve as members of the standing committees of the Council. The
53 representative of the Utah State Bar may vote at meetings of the Board of
54 Commissioners if permitted to vote under rules governing the conduct of the Board of
55 Commissioners.
