

1 **Rule 24. Intervention.**

2 (a) **Intervention of right.** On timely motion, the court must permit anyone to intervene who:

3 (a)(1) is given an unconditional right to intervene by a statute; or

4 (a)(2) claims an interest relating to the property or transaction that is the subject of the action, and
5 is so situated that disposing of the action may as a practical matter impair or impede the movant's
6 ability to protect its interest, unless existing parties adequately represent that interest.

7 (b) **Permissive intervention.**

8 (b)(1) **In General.** On timely motion, the court may permit anyone to intervene who:

9 (b)(1)(A) is given a conditional right to intervene by a statute; or

10 (b)(1)(B) has a claim or defense that shares with the main action a common question of law
11 or fact.

12 (b)(2) **By a Government Officer or Agency.** On timely motion, the court may permit a federal or
13 state governmental officer or agency to intervene if a party's claim or defense is based on:

14 (b)(2)(A) a statute or executive order administered by the officer or agency; or

15 (b)(2)(B) any regulation, order, requirement, or agreement issued or made under the statute
16 or executive order.

17 (b)(3) **Delay or Prejudice.** In exercising its discretion, the court must consider whether the
18 intervention will unduly delay or prejudice the adjudication of the original parties' rights.

19 (c) **Notice and motion required.** A motion to intervene must be served on the parties as provided
20 in [Rule 5](#). The motion must state the grounds for intervention and set out the claim or defense for which
21 intervention is sought.

22 (d) **Constitutionality of Utah statutes, ordinances, rules, and other administrative or legislative**
23 **enactments.**

24 (d)(1) **Challenges to a statute.** If a party challenges the constitutionality of a statute in an action
25 in which the Attorney General has not appeared, the party raising the question of constitutionality
26 shall notify the Attorney General of such fact by serving the notice on the Attorney General by email
27 or, if circumstances prevent service by email, by mail at the address below. The party shall then file
28 proof of service with the court.

36 (d)(2) **Challenges to an ordinance or other governmental enactment.** If a party challenges
37 the constitutionality of a governmental entity's ordinance, rule, or other administrative or legislative

38 enactment in an action in which the governmental entity has not appeared, the party raising the
39 question of constitutionality shall notify the governmental entity of such fact by serving the person
40 identified in Rule 4(d)(1) of the Utah Rules of Civil Procedure. The party shall then file proof of service
41 with the court.

42 (d)(3) **Notification procedures.**

43 (d)(3)(A) **Form and content.** The notice shall (i) be in writing, (ii) be titled “Notice of
44 Constitutional Challenge Under URCP 24(d),” (iii) concisely describe the nature of the
45 challenge, and (iv) include, as an attachment, the pleading, motion, or other paper
46 challenging the constitutionality of the statute.

47 (d)(3)(B) **Timing.** The party shall serve the notice on the Attorney General or other
48 governmental entity on or before the date the party files the paper challenging the
49 constitutionality of the statute.

50 (d)(4) **Attorney General’s or other governmental entity’s response to notice.**

51 (d)(4)(A) Within 14 days after the deadline for the parties to file all papers in response to the
52 constitutional challenge, the Attorney General or other governmental entity (“responding entity”)
53 shall file a notice of intent to respond unless the responding entity determines that a response is
54 unnecessary. The responding entity may seek up to an additional 7 days’ extension of time to file
55 a notice of intent to respond.

56 (d)(4)(B) If the responding entity files a notice of intent to respond within the time permitted by
57 this rule, the court will allow the responding entity to file a response to the constitutional challenge
58 and participate at oral argument when it is heard.

59 (d)(4)(C) Unless the parties stipulate to or the court grants additional time, the responding
60 entity’s response to the constitutional challenge shall be filed within 14 days after filing the notice
61 of intent to respond.

62 (d)(4)(D) The responding entity’s right to respond to a constitutional challenge under Rule
63 25A of the Utah Rules of Appellate Procedure is unaffected by the responding entity’s decision
64 not to respond under this rule.

65 (d)(5) **Failure to provide notice.** Failure of a party to provide notice as required by this rule is not
66 a waiver of any constitutional challenge otherwise timely asserted. If a party does not serve a notice
67 as required by this rule, the court may postpone the hearing until the party serves the notice.
