HEARINGS

All hearings will be conducted remotely unless exigent circumstances have been established for an in-person hearing. Remote hearings may be attended either by Webex video connection or by telephone. You should receive an email prior to the hearing containing instructions on how to attend remotely. Please contact the court to provide your email address if you have not already done so, or if the email address has changed. If you have difficulty connecting to the hearing or have not received the hearing information, please contact the court directly at 801-334-4700.

ELECTRONIC FILING OF DOCUMENTS

Individuals who have an assigned or privately retained attorney should work with them to file any documents pertaining to their case.

Self-represented litigants or any individuals who do not have access to eFiling through an attorney may electronically file motions and other pleadings by emailing an image (preferably a PDF) of the filing.
