**Having the opportunity of working off your court obligations on the Work Crew is a privilege. Violating any of the below conditions, or any other conditions given at an orientation, may result in your privilege of working on the Work Crew program being suspended.**

### Work Behavior

1. I agree not to use profane language, such as; curse words, lewd comments, derogatory remarks, discussion of illegal activity and/or anything gang related or anything deemed inappropriate by a Deputy Probation Officer (DPO).
2. I agree not to engage in any illegal behavior or acts and I understand that in the event illegal behavior occurs, law enforcement will be contacted.
3. Parents must contact the county hotline number to verify that the Work Crews are running that day.
4. Youth must attend a minimum of one day a week.
5. All hours are to be completed on the Work Crews unless pre-approved by a Judge, Probation or DPO Supervisor. Youth will not be able to work hours "off crew and "on crew" at the same time.

### Work Apparel

1. I agree to come to work dressed appropriately for working conditions suitable for painting and a variety of other work assignments. Apparel should be appropriate to the weather conditions.
2. Apparel should be free of profanity, gang affiliation or anything inappropriate.
3. Low-cut shirts, exposed midriffs, tank tops and sleeveless shirts are not allowed. Shorts should be within three inches of the knee. Sagging pants will not be allowed. No open-toed shoes or sandals can be worn.
4. I understand that if I come to work crew dressed inappropriately, I may be sent home and if sent home it will be considered an un-excused absence.

### Consent and Permission

1. I consent to search and seizure conducted by Juvenile Court Personnel at anytime while under work crew supervision. Markers, lighters, matches, weapons of any kind, or any other illegal or inappropriate items will be confiscated and could result in possible suspension or contact of law enforcement.
2. Cell phones and iPods cannot be operated while on the crews. If I choose to bring these items, they will be held by the DPO and returned at the end of the work day. Work Crew is not liable for the security of the these items.
3. Work Crew groups may be photographed (optional) for display purposes for court use. \_\_\_\_\_ *Initial if you wish not to allow your child to be photographed while on the work crews.*
4. I consent to having first aid administered if needed.
