

**ORDER ASSSIGNING SUBDIVISION  
SUB-CASE NUMBERS FOR OBJECTION  
PROCEEDINGS, AND GOVERNING  
FILING OF DOCUMENTS IN  
SUBDIVISION SUB-CASES**

THE COURT, in consultation with the duly-appointed Special Master, determines that the management of this large and complex case requires the assignment of separate civil numbers to its various adjudicative subdivision sub-cases. Accordingly, the Court orders the following:

1. This Order is to be read in conjunction with the "Order Governing Filing of Documents" entered on December 19, 1994, which requires that each pleading filed in the general case file include the name of the specific adjudicative subdivision (*e.g.*, Spanish Fork, Bk 1) in the caption of the pleading. In the event of conflicting provisions, this Order shall govern.

2. Effective as of the date of this Order, all pleadings relating to (i) a list of unclaimed rights or (ii) an objection to a proposed determination (hereinafter referred to as an "Objection Proceeding") shall be filed under the separate civil number assigned by this Order to the applicable subdivision, as follows:

3. As additional subdivisions are designated by the State Engineer, the Court will, upon motion from a party or *sua sponte*, assign civil numbers to the additional subdivision sub-case. Once a civil number has been assigned, all pleadings relating to any Objection Proceeding shall be filed under the separate civil number assigned to the applicable subdivision.

4. In the event that a pleading has been filed in the wrong subdivision sub-case, the Clerk of the Court shall re-file it in the proper sub-case upon order of the Special Master. In addition, the Special Master may order that pleadings originally filed in the general case (Case No. 360057298) also be filed in one or more subdivision sub-cases as appropriate.

5. In addition, the Special Master will assign each Objection Proceeding a three-number set. For example, the three-number set for the Hardy and Norma Child Objection Proceeding in Spanish Fork Subdivision, Book 1, is 51-1-01. Pursuant to the Special Master's "Order Approving Numbering of Sub-Cases in Subdivisions 51-1, 51-2, 54-1, 59-1, and 59-2" entered November 2, 2016, which is incorporated into this Order, the Special Master has assigned a three-number set to each Objection Proceedings in Spanish Fork, Books 1 and 2; Cedar Valley, Book 1; Salt Lake County Northwest; and the Salt Lake County, Central, Book 2, Subdivisions.

6. Pleadings filed in a subdivision sub-case after the effective date of this Order shall include, on the left side of the case caption, directly under the name of the subdivision and book number, the three-number set assigned to the particular Objection Proceeding by the Special Master. The three numbers in this set shall be separated by hyphens, *i.e.*, "XX-X-XX".

7. To facilitate browser-searching of the Court's on-line docket, each pleading e-filed in any subdivision sub-case shall include, in the title input into the Court's Xchange or GreenFiling systems, the three-number set assigned to the Objection Proceeding so that the

Court's on-line docket can be effectively searched for the three-number set employing standard search functions in commonly-used web browsers.


8. Thus, pleadings filed in a subdivision sub-case after the effective date of this Order shall have a caption in substantially the form as shown in the following example:

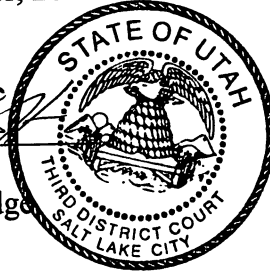

9. Counsel wishing to receive electronic notices in a particular subdivision sub-case must file a separate notice of appearance in each such sub-case. Although counsel need only file one notice of appearance per subdivision sub-case, the notice of appearance must be linked in e-filing to each Objection Proceeding that counsel wishes to be associated with for purposes of receiving electronic notices. To do so, counsel shall indicate each such Objection Proceeding by selecting in the Court's Xchange or GreenFiling system (via the drop-down menu) that counsel is appearing on behalf of the original objector(s) in each Objection Proceeding(s) within the subdivision sub-case in which counsel will be involved, *i.e.*, counsel should associate his or her name with the party who initiated the Objection Proceeding by the filing of the original objection to a proposed determination or list of unclaimed rights. If the actual party that counsel is

representing has already appeared in the subdivision sub-case, counsel shall also indicate in the Court's Xchange or GreenFiling system that counsel is also appearing on behalf of that party.
