 5. I understand that if I am adopted, the adopting parent will be known as my parent and I will be known as his or her child. I understand that I may take his or her family name.
 6. Understanding all of this, I voluntarily waive my right to be notified of hearings and served with papers in this matter, and I voluntarily waive my right to intervene in this matter.
 7. Understanding all of this, I voluntarily consent to be adopted.
