- (4) The temporary guardian is charged with the care and custody of the above-named respondent/protected person and is authorized to exercise the following authority:

- (5) The temporary guardian shall not permit the above-named respondent/protected person to be removed from the state.
- (6) Upon acceptance by the temporary guardian, the clerk of court shall issue an appropriate letter of temporary guardianship.
- (7) The clerk of the court shall schedule a hearing no more than five days from the date of this order.
- (8) The temporary guardian shall serve this order and a notice of hearing on all persons required by law to be served.
- (9) If a Petition to Appoint a Guardian is filed before the hearing, the petitioner shall serve a copy of the petition on all persons required by law to be served.
